**DC Limited Purpose driver license:**

On May 1st the Department of Motor Vehicles will begin accepting applications for Limited Purpose driver license. To obtain a Limited Purpose driver license you must:

- Schedule an appointment with the Department of Motor Vehicles by clicking [here](#). Applicants who try to walk in without an appointment will be turned away.
- Take and pass a knowledge test, skills road test and meet eligibility requirements.
- Be a resident of the District of Columbia for at least 6 months from the date of application.
- Have never been issued a social security number; or previously been issued a social security number but no longer eligible; or not be eligible for a social security number.

The Limited Purpose driver license may not be used for official federal purposes, and it will be marked to reflect this requirement.
